- For claim request, Ponte Tresa will only cover the cost of the roses. and will not cover shipping or handling costs. Quality problems must be reported in writing 48 hours after receipt of flowers. If we do not receive a written notification within this period it will be understood that the products were received in satisfactory conditions and no further claims will be accepted.**
- If this account is placed for collections and it becomes necessary to collect the sum owed or any part of the sum, I/we will pay any and all costs incurred in collection including service fees, attorney fees and interests.

I/we authorize Ponte Tresa to make any credit investigation as necessary through any available sources, trade references, banks, or credit reporting agencies to disclose any and all information concerning the financial and credit history of the company.
